Ongoing projects

- o WMA 17 Reports for the surveyed properties will be done over the winter
- GLRI FA2 Planning for upcoming field season and determination of plots for planting will be done over the winter months.
- O GLRI Pathways we received and extension on the final product and were planning on meeting in early January to catch up where everyone is at. TIP is working with WHIP and WRISC on this project. When we broke up the workload for this TIP took the task of writing the information, WRISC took the task creating images and WHIP has taken the task of formatting the final product. So far all of the pages are written they just need to be reviewed and formatted.
- Town of Upham this fall TIP performed a survey of the town of Upham in langlade county and found a few patches of Japanese knotweed we were able to do some control work on. We looked again once the leaves dropped and thankfully did not find any buckthorn or honeysuckle on the town roads. We will do another survey in the spring/summer for plants like wild parsnip.
- MITW Contract TIP has been working with MITW and Menominee County quite a bit recently to control a dense and extensive population of buckthorn and honeysuckle off of Old South Branch Road where Timber Trail turns off of it on some LLPOA land. We are planning on continuing control efforts throughout the winter as long as the money allows, but I will also save some to be used on that patch of Wild Parsnip just off the Reservation off of Camp 26 Road. This account is not listed above but is categorized as 137P, began with \$5000 and is currently at \$4,005.10
- Town of Rolling Currently the town has a draft of a contract similar to the one we have with the Town of Upham. We are anticipating \$1,500-\$2,500 to before inventory and control on their town roads. They border Marathon County and Wild Parsnip very prevalent in that area.
